COMES NOW the Defendant/ Combatant /Petitioner(s) Pastor Martin Luther Dzerzhinsky Lindstedt, of the Church of Jesus Christ Christian / Aryan Nations of Missouri, The Ten Thousand Warlords Political Action Committee, and the sub-corporation Newton County Geldings & Walking Wombs, etc. as a Revolutionary entity given Granby Municipal Corporate treason and corruption to make the following miscellany of Motions under contract for the following admissions of fact:


